Sine Burr XII Distribution: Properties and Application to Real Data Sets

ABSTRACT

Sine G family, Burr XII, Moment, Moment generating Function, Maximum likelihood Estimators. New parameters can be added to expand families of distribution for greater flexibility or to construct covariate models in several ways. In this paper, a trigonometric-type distribution was developed to generate a flexible distribution without adding additional parameters taking the Burr XII distribution as the base distribution. The new distribution is called the Sine-Burr XII distribution. Some of the mathematical properties of this distribution such as the moment, moment generating function, entropy and order statistics were derived. The parameters of the new distribution were estimated using the Maximum Likelihood method. The applicability of the Sine-Burr XII distribution was illustrated using two real datasets.

INTRODUCTION

The accuracy of parametric statistical inference and modelling of data sets largely depends on how well the probability distribution fits the given data sets once it has met all the necessary distributional

assumptions. Many pieces of research have been conducted on statistical distribution in search to generate distribution with more desirable and adjustable properties that can be models real-life data sets of the varying form of density and failure rate functions.

Presently most studies are focused on developing new families that are a generalisation of existing distribution to obtain a better fit for the modelling of data. These families of distribution are obtained by either compounding two or more distributions or adding one or more parameters to the baseline model. Many writers have substantial reviewed the various families of distribution (Hamedani *et al.*, 2018).

The main reason for developing this family is to improve the flexibility of the existing classical distribution, thus enabling them to provide a better fit to the survival data set than other distributions with the same number of parameters and model different kinds of failure rates (Motonic and non-motonic).

The Burr system of distribution comprises 12 types of cumulative distribution functions

which give a variety of density forms. The desirability of this relatively unknown family of distribution for model fitting is that it combines a simple mathematical expression for cumulative frequency function with coverage in the skewness-kurtosis plane. standard theoretical distributions including the Weibull, exponential, logistic, generalized logistic. Gompertz. normal extreme value and uniform distribution are special cases of limiting cases of the Burr types system of distribution.

The family of Burr type distribution is a very well-known distribution family for modelling survival data and for modelling phenomena with monotone and unimodal failure rates. In most areas of application, the Burr distribution of any type is adequate and as such various generalizations and extensions of the Burr, distributions have been suggested in the statistical literature.

The cumulative density function for a random variable **X** having a Burr XII distribution is given by:

The probability density function (pdf) of a Burr XII distribution for the random variable \mathbf{X} is also given by:

The trigonometric transformations provide versatility and flexibility as the parameter(s) oscillate with change in its value and the periodic function controls the way the distribution curve behaves. The composition of various functions with different behaviour provides a better make for modelling real-world phenomena which the previous established generalized statistical distributions lacked. With the suitable composition of

trigonometric functions and generalized distributions by considering the parameters suiting to data to be modelled, the shortcoming is minimized or better said the distribution becomes apt to model data of different nature and gives rise to even newer transformed distribution to work with.

Some of the recently developed trigonometric distributions include an exponentiated sine-

generated family of distributions by Muhammad *et al.* (2021), Sin-G class of distributions by Souza *et al.* (2019), sine square distribution by Al-Faris and Khan (2008), Sine Inverse Lomax Generated Family

METHODOLOGY

Sine G Family of Probability Distribution

given continuous probability distribution. It is used for obtaining some moments like

skewness and kurtosis as well as the median

and for the generation of random variables

from the distribution in question (Hyndman & Fan 1996). The survival function is given by

The New Sine Burr XII Distribution

The pdf of the newly developed Sine-Burr XII distribution is given by:

Hazard Function

The hazard rate function is a significant quantitative exploration of life phenomenon. The hazard rate function measures the conditional instantaneous rate of failure at time x, given survival to time x. Barlow et al., (1963) introduced hazard rate function, in studying the relationship between properties of a distribution function (or

It has significant value in the study of reliability analysis, survival analysis, actuarial sciences and demography, in extreme value theory and in duration analysis in economics and sociology. The hazard function which is denoted by h(x; a, b) is given as

where f(x; a, b) and F(x; a, b) are the pdf and cdf of the Sine-Burr XII distribution given in equation (5) and (6) respectively.

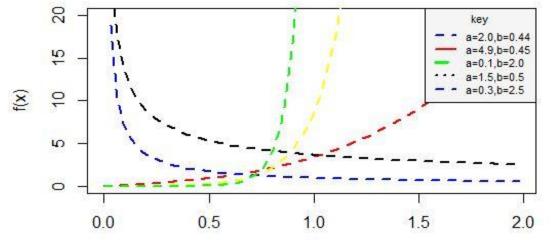

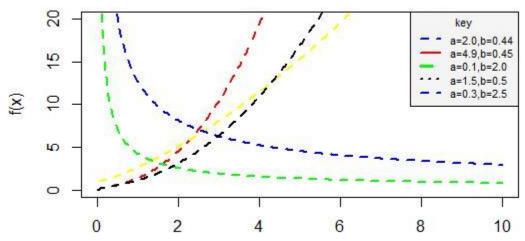

Mathematical Properties

Moment Generating Function

The moment generating function of a random variable X is the expected value of e^{tx} . We say that the moment generating function exist if there exists a positive constant a such that $M_x(t)$ is finite for $\forall t \in [-a, a]$.

Entropy

Entropy is used as a measure of information or uncertainty, which is present in a random observation of its actual population. There will be greater uncertainty in the data if the value of entropy is large. The Shannon entropy for the true continuous random variable X is defined as:

Order Statistics

Let $X_1, X_2, ..., X_n$ be a random sample of size n from a continuous population having a pdf f(x) and distribution function (cdf) F(x), Let $X_{1:n} \le X_{2:n} \le X_{n:n}$ be the corresponding order statistics (OS). David (1970) defined the pdf of $X_{r:n}$ that is the r^{th} OS by:

Parameter Estimation

In this paper, we explore the maximum likelihood technique to estimate the unknown parameters of the Sine-Burr XII distribution for complete data. Maximum likelihood estimates (MLEs) have appealing qualities that may be used to generate confidence ranges

and provide simple approximations that function well in finite samples. In distribution theory, the resulting approximation for MLEs is easily handled, either analytically or numerically. Let $x_1, x_2, x_3, ..., x_n$ be a random sample of size n from the Sine-Burr XII distribution. Then, the likelihood function of the Sine-Burr XII is given as follows:

Equation (18) and equation (19) gives the maximum likelihood estimators of the parameters a and b of the Sine-Burr XII distribution.

RESULTS AND DISCUSSION

Application

Two datasets were considered for illustrative purposes and comparison with Burr XII (BXII) and Extended Burr XII distributions. For each data set, we estimate the unknown parameters of each distribution by the maximum-likelihood method. We obtain the values of the Akaike information criterion (AIC), Bayesian information criterion (BIC) and consistent Akaike information criterion (CAIC).

First Dataset

We consider Vinyl Chloride data of sample thirty-four obtained from clean up gradient monitoring wells in mg/L; this data set was used by Bhaumik et al. (2009). The data are as follows: 5.1, 1.2, 1.3, 0.6, 0.5, 2.4, 0.5, 1.1,

8.0, 0.8, 0.4, 0.6, 0.9, 0.4, 2.0, 0.5, 5.3, 3.2, 2.7, 2.9, 2.5, 2.3, 1.0, 0.2, 0.1, 0.1, 1.8, 0.9, 2.0, 4.0, 6.8, 1.2, 0.4, 0.2

Second Dataset

The second dataset consists of thirty successive values of March precipitation (in inches) in Minneapolis/St Paul (Hinkley, 1977). The data are as follows: 0.77, 1.74, 0.81, 1.2, 1.95, 1.2, 0.47, 1.43, 3.37, 2.2, 3, 3.09, 1.51, 2.1, 0.52, 1.62, 1.31, 0.32, 0.59, 0.81, 2.81, 1.87, 1.18, 1.35, 4.75, 2.48, 0.96, 1.89, 0.9, 2.05

Table 1 and table 2 gives the summary statistics of the two data sets such as the mean, the median, the first and third quartile, the minimum and the maximum values.

Table 2 gives the results of the analysis of the two datasets. The results of the analysis of the Sine-Burr XII were compared with Burr XII distribution and Extended Burr XII distribution. The proposed Sine- Burr XII distribution has proven to be the better model because it has the least AIC, CAIC, BIC and HQIC. It can be seen that the proposed model outperformed its competitors with minimum AIC, BIC, CAIC and HQIA.

CONCLUSION

There has been a growing interest among statisticians and applied researchers in developing flexible lifetime models for the betterment of modelling survival data. In this paper, we introduced a two-parameter Sine-Burr XII distribution which is obtained by considering a Burr XII distribution as the baseline. We study some of its statistical and mathematical properties. Maximum Likelihood Estimation was used in parameter estimation. The usefulness of the new distribution was illustrated via the analysis of two real data sets. We hope that the proposed extended model will attract wider applications in survival analysis.
