# Acute Toxicity Testing and Phytochemical Screening of Hydromethanolic Leaf Extract of *Maerua angolensis* on Albino Wistar Rats

## ABSTRACT

**Keywords:** Maerua angolensis leaves have been used traditionally for the treatment of Medicinal Plants, several ailments which include but not limited to anaemia, jaundice, arthritis, Toxicity, insomnia, liver diseases and neurological disorders. Despite its widespread Maerua angolensis, use and several reported beneficial uses, there is a paucity of data on its Phytochemicals toxicity potential. This study was therefore designed to evaluate the phytochemical constituents and acute toxicity potential of hydromethanolic leaf extract of Maerua angolensis on albino wistar rats. Phytochemical screening was carried out using a standard procedure for the identification of phytochemicals as described in the literatures. Acute toxicity determination was done in two phases (using Lorke's method). In the first phase, the rats were divided into three groups of three rats each and were administered 10mg/kg, 100mg/kg and 1000mg/kg body weight of the hydromethanolic leaf extract of Maerua angolensis respectively. In the second phase, the rats were divided into three groups of one rat each and were administered 1600mg/kg, 2900mg/kg and 5000mg/kg body weight of the hydromethanolic leaf extract of Maerua angolensis respectively. Phytochemical screening revealed that the hydromethanolic leaf extract of Maerua angolensis contains flavonoids, cardiac glycosides, saponins, tannins and terpenoids. The rats did not show any signs or symptoms of toxicity following the administration of the extract during both phases. Therefore, it could be concluded that Maerua angolensis leaves contain essential constituents needed in the treatment and management of various ailments and are also safe for use as the  $LD_{50}$  was >5000mg/kg supporting its folkloric use in disease management.

#### INTRODUCTION

Plants have been used for medicinal purposes since ancient times and their importance and vitality have been appreciated by the human population (Fateemah et al., 2018). Traditional medicines have been reported to be safe and relatively non-toxic as a result of their long history of use globally, especially in developing countries (Yuet et al., 2013). However, the unguided traditional use of plants has been implicated in the cause of short- and long-term health complications (Cock, 2015). Scientific studies have shown that the medicinal values and efficiency of these plants are due to the presence of certain phytochemical substances that produce definite physiological responses in the human body (Edeoga et al., 2005).

Screening of these phytochemicals is considered a valuable procedure in the detection of the bioactive constituents present in medicinal plants and subsequently leads to the discovery and development of new and efficient drugs (Yadav *et al.*, 2014). In addition, the screening can also be used to identify toxic compounds present in such plants.

Recent studies questioned have the bioactivities of traditionally used medicinal plants due to reported side effects associated with their usage in both humans and animals (Nath, 2015). Acute toxicity study investigates the safety profile of a plant within a short period. It involves the evaluation of the adverse effects and reactions that occur following exposure of experimental animals to single or multiple doses of test substances within 24 hours by either oro-gastric, dermal or intraperitoneal routes (Saganuwa, 2016). The conventional measure of acute toxicity is the LD50 (median lethal dose) which was first introduced in 1927 by J. W. Trevan to estimate the dose of a test substance that produces 50% death in a given species of animals (Earnest *et al.*, 2018). Although the major observational endpoint in acute toxicity testing is death, non-lethal acute effects may occur as signs of toxicity depending on the testing chemical (Maheshwari and Shaikh, 2016).

Maerua angolensis belongs to the family "Capparaceae" comprising more than 50 species and are found mostly in the drier areas of tropical Africa as well as in the Middle East and tropical Asia. The English name for Maerua angolensis is Bead-bean, bush veld, or bead maerua; Its Fulani name is Leggel Baali (tree of sheep): Its Arabic name is Shegara el zeraf (Giraffe tree); and its Hausa name is Babbajuyi; while its Kanuri name is Apci (Mothanna et al., 2009). Several studies have shown that phytochemical constituents of plants have potential use as drugs, and the pharmacological activity of these substances serves as the basis for their use in modern medicine based on scientific evidence (Ahn, 2017). Therefore, the medicinal values of plants depend on the chemical substances in them that produce certain physiological actions which range from cell toxicity to cell protective effects. The most important of these bioactive substances in medicinal plants include alkaloids, tannins, flavonoids, saponins, cardiac glycosides and phenolic compounds (Krishniah et al., 2009). Methanolic extract of Maerua angolensis leaves has been reported to contain carbohydrates, reducing sugars, alkaloids, cardiac glycosides, saponins, flavonoids and tannins while its petroleum ether extract showed the presence of alkaloids, cardiac glycosides and saponins (Ayo et al., 2012).

*Maerua angolensis* leaves have a long history of use traditionally in the management of various ailments (SEPASAL, 2012). The leaves are used medicinally, either alone or in combination with other drug plants, to treat a range of human ailments including stomach aches, asthenia, anorexia, headaches, and rheumatism (Yusuf et al., 2017). Maerua angolensis extract inhibits vincristine-induced peripheral neuropathy in mice suggesting that it may exert an analgesic effect in cancer patients with neuropathic pain and an antinociceptive effect in abdominal constrictions (Iliva et al., 2016). The stem of *Maerua* angolensis also bark extract protects the generation of free radicals and oxidative products of pentylenetetrazoleinduced oxidative stress and seizures in rats (Charles et al., 2018). Maerua angolensis is a potential source of antibiotics with a broad spectrum of activity as demonstrated by the antimicrobial activity of the leaf extract against pathogenic microorganisms (Amina et al., 2017). The powdered leaves are laid over hard pus-filled abscesses to maturate them and

the leaf sap is dropped on fresh wounds as an antiseptic dressing (Latham, 2007). In Nigeria, the fruits are used by youths as a love charm, mixed with tozali (galena, or so-called antimony) and rubbed on the eyelids to render themselves irresistible to girls (Adamu *et al.*, 2007) and the plant was reported to be used in the treatment of arthritis by the Hausas of North-western Nigeria (Magaji *et al.*, 2009; Mohammed *et al.*, 2008).

Unfortunately, little or no attention has been paid in the literature to the examine the phytochemical constituents and toxicity potential of this plant despite its widespread use. Hence, this study was aimed at evaluating the acute toxicity and phytochemical constituents of the hydromethanolic leaf extract of *Maerua angolensis* on albino wistar rats.

#### METHODOLOGY

#### **Plant Collection and Identification**

Leaves of the plant were obtained from Yola, Adamawa State Northeastern Nigeria and authenticated by a botanist in the Department of Biological Sciences, University of Maiduguri. The leaves were air-dried at room temperature to preserve the heat-labile compounds.

#### **Experimental Animals**

A total of twelve (12) male and female albino wistar rats weighing 180-200g were obtained and kept in separate well-aerated laboratory cages in the animal house, College of Medical Sciences, University of Maiduguri. The animals were allowed to acclimatize to the laboratory environment for a period of two weeks before the commencement of the experiment. They were allowed access to feed and water ad libitum throughout the period of the experiment.

#### **Preparation of Extract**

The extract was prepared using the method employed by Erica et al. (2016). 1000g of the grounded leaves of Maerua angolensis was dissolved in five litres of methanol and allowed to stand for 48 hours. The resulting suspension was filtered and the residue was extracted further. The filtrate was concentrated using a rotary evaporator with the aid of a pump. The concentrate vacuum was evaporated further to dryness in a vacuum oven at  $50^{\circ}$ C and the powder obtained (56.5g) was stored in a refrigerator until use.

The percentage yield was calculated in terms of air-dried weight of the plant material as:

Percentage yield =  $\frac{Weight of Extract obtained(g)}{Weight of Initial sample(g)} X 100$ 

#### Phytochemical Screening of Hydromethanolic leaf extract of Maerua angolensis

Phytochemical screening was carried out using the standard procedure for the identification of phytochemical constituents as described by Harborne, (1973); Trease and Evans, (1983) and Sofowora, (1993). The extract solution was prepared by dissolving 10g of extract in distilled water to make up a 100 ml solution. The extract solution was then used for phytochemical screening. Tests were done for confirmation of alkaloids, flavonoids, cardiac glycosides, anthraquinones, terpenoids, tannins, starch. phlobotannin and carbohydrates.

### Determination of Median Lethal Dose $(LD_{50})$

The LD<sub>50</sub> was determined by a procedure described by Lorke (1983) using 12 rats. In the first phase, nine (9) rats were divided into 3 groups of 3 rats each and were treated with the hydromethanolic leaf extract of Maerua angolensis at doses of 10mg/kg, 100mg/kg and1000mg/kg body weight orally. They were observed for 2 weeks for signs of toxicity and mortality. In the second phase, three (3) rats were divided into three (3) groups of one (1) rat each and were treated with the extract at doses of 1600mg/kg, 2900mg/kg, and 5000mg/kg body weight orally and were observed for 24hours for signs of toxicity or mortality. From the results of the two phases, the LD<sub>50</sub> was determined.

#### RESULTS

#### DISCUSSION

Phytochemical screening of the hydromethanolic leaf extract of Maerua angolensis revealed presence the of cardiac flavonoids, glycosides, tannins, terpenoids, saponins, and carbohydrates. Anthraquinones, Alkaloids, soluble starch, and phlobatanin were absent. This is in agreement with previous studies reported by Ayo et al. (2012) that were conducted in Zaria, Kaduna state of Nigeria, and that of Amina et al. (2017) conducted in Katsina State of Nigeria; although, in addition, the present study revealed the presence of terpenoids and absence of alkaloids. The methanolic stem extract of Maerua angolensis also bark revealed the presence of saponins, steroids, tannins, flavonoids, alkaloids, glycosides, carbohydrates and terpenoids, proteins (Adamu et al., 2007; Mohammed et al., 2008; Magaji et al., 2009). These differences might be attributed to variations in the nature of soil of the two geographical regions or the part of the plant used during the screening or might be due to the differences in the extraction methods used. Tannins are reported to possess antioxidant and anti-microbial potencies (Majid, 2013). Flavonoids are significantly recognized for their antioxidant, anti-carcinogenic, antimicrobial and anti-tumour properties (Okwu,

2001). Polyphenols and flavonoids scavenge free radicals such as peroxide, hydroperoxide or lipid peroxyl and thus inhibit oxidative mechanisms that lead to degenerative diseases (Lee et al., 2014). They are therefore necessary for preventing haemolytic diseases such as anaemia (Upadhyay and Dixit, 2015). Epidemiological studies revealed that flavonoid prevents the oxidation of lowdensity lipoproteins, and lowers blood cholesterol level and triglycerides, thereby reducing the risk of atherosclerosis (Subramani and Casmir, 2002). Terpenoids are naturally occurring hydrocarbons produced by a wide variety of plants and animals. Important therapeutic uses of terpenoids include antioxidant, antimicrobial, antifungal, anti-inflammatory, antiparasitic, antiviral. hyperglycemic, immunomodulatory and skin permeation enhancer (Priyarka and Pathik, 2013). Saponins have been reported to have beneficial effects on blood cholesterol levels (Oyewole and Akingbala, 2011). Saponin glycosides are amphipathic glycosides that act as surfactants i.e., they possess detergent properties (Bissinger et al., 2014).

The median lethal dose (LD50) of hydromethanolic leaf extract of *Maerua angolensis* using Lorke's method did not reveal any signs and symptoms of toxicity or mortality after oral administration of the

extract following observation in the first phase and the second phase even at the highest dose of 5000mg/kg body weight (Table 2). Therefore, this result gives the impression that the lethal doses for the extract must be higher than 5000 mg/kg body weight, which is the highest reference dose (Nanthini et al., 2014). In this regard, the extract may be considered safe at the tested levels of 5000 mg/kg body weight and below as consistent with a previous study of acute toxicity (Nanthini et al., 2014: Olaniyan et al., 2015: Porwal et al., 2017). Since the LD50 test of hydromethanolic leaf extract of Maerua angolensis could not reveal dreadful outcomes from all doses subjected, then it can be postulated that the compounds in the extract probably do not express any deleterious effects in rats.

#### CONCLUSION

Because the hydromethanolic leaf extract of *Maerua angolensis* contains some essential phytochemical constituents needed in the management of various ailments coupled with its non-toxic potential, the extract is therefore considered to be relatively safe for use.

#### RECOMMENDATIONS

Because our findings are essentially preliminary and could benefit from further investigations, the following recommendations are made;

1. Quantitative phytochemical screening be carried out on the hydromethanolic leaf extract of *Maerua angolensis* 

2. A sub-acute and chronic toxicity evaluation experiment be conducted for histopathological examination of cells and to determine long-term effects of the hydro methanolic leaf extract of *Maerua angolensis*.

3. Further toxicity study should be considered using different animal models.
