# Evaluation of Heavy Metal concentrations in Groundwater in a Mining Community: A Case Study of Funakaye LGA, Gombe State

Based on this, groundwater quality in Funakaye area was investigated because mining operations had occurred there for a long time. This study was aimed at analyzing the quality of groundwater in Funakaye, with emphasis on heavy metal contamination. Groundwater samples were obtained from three boreholes in triplicate, and analysed for heavy metal concentration using Atomic Absorbtion Spectrophotometer (AAS) machine. The concentrations were compared to the WHO and NESREA standard limits for quality drinking water. The results showed that heavy metal concentrations in the boreholes were generally high, with Fe ranging from 0.369mg/l to 0.490mg/l, Cd ranging from 0.008mg/l to 0.011mg/l, Cr ranging from 0.489mg/l to 1.115mg/l, thus exceeding the WHO and NESREA recommended limits. Zn and Cu concentrations in the samples were found to be lower than the recommended limits for drinking water, with Zn ranging from 0.009mg/l to 0.178mg/l and Cu from 0.063mg/l to 0.102mg/l. The concentrations obtained for the parameters studied revealed that the sampled boreholes in Funakaye have characteristics of heavy metal contamination in groundwater. Using water from these sources for domestic purposes, including drinking, may lead to fatal cases of arsenic poisoning, cancer, tissue damage, anaemia and neurodegenerative diseases and the study recommends that a continuous water monitoring programme be developed to check and ensure appropriate actions are implemented, as well as the drilling of deep motorised boreholes far away from the contaminant site. In addition, the government should raise community awareness of potential hazards of environmental

# **INTRODUCTION**

Water and sanitation are fundamental needs for life on Earth (Mara and Evans, 2011). According to the United Nations Sustainable Development Goals on Water and Sanitation, around 2.4 billion people worldwide live in regions designated as experiencing water stress (UN SDGs Report, 2023). The availability of water resources, both in terms of quantity and quality, is critical for addressing resource sustainability. The rapid increase in global population growth has led to heightened food production, thereby exerting significant pressure on water resources (Kalaivanan et al., 2017). Recently, individuals have turned to groundwater for drinking purposes, particularly in poorer nations (Massally et al., 2017). Observations indicate an increased dependence on groundwater supplies due to quality concerns related to surface water use. The quality of groundwater varies regionally due to geogenic and anthropogenic influences Janardhana, (Annapoorna and 2015), necessitating an evaluation of water quality for its intended application. The assessment of groundwater quality is crucial for socioeconomic advancement (Ishaku, 2011). The assessment of water quality for human consumption, agricultural, and industrial purposes has received insufficient attention, particularly in developing countries such as Nigeria. The chemical composition of water can render it unsuitable for human consumption, potentially resulting in health issues. Recent studies have highlighted the significance of groundwater quality in relation to human health (Vasanthavisar et al., 2010). In developing countries, 80% of diseases are directly associated with inadequate drinking water and unsanitary conditions (UNESCO, 2006).

Mining activities may cause detrimental changes to the ecosystems of adjacent communities. These changes impact populations not only via life-threatening diseases but also through the degradation of essential natural resources like groundwater. Groundwater is an important resource for billions of people globally, used largely for drinking, household chores, industrial and agricultural purposes. However, this critical resource is sometimes severely contaminated, owing mostly to industrial discharge, agricultural runoff, and insufficient waste management techniques. Heavy metals such as

Arsenic, Iron, Manganese, Lead, as well as nitrates, offer major health concerns and environmental damage (Argos et al., 2010; Chakraborti et al., 2015; Ghosh et al., 2020; Islam and Mostafa, 2021; Chakraborty et al., 2022). Groundwater contamination by heavy metals arises from the normal weathering of mineral-bearing rocks and human activities. These activities, including coal mining, mineral extraction, industrial discharge, and fertilizers, substantially contribute to the contamination of groundwater with heavy metals (Gupta and Nikhil, 2016). Groundwater contaminants originate from both point sources, such as mining spills, and non-point sources, such as agricultural waste. Mine wastes produce Acid Mine Drainage (AMD), which contains elevated levels of Sulphidebearing compounds and has the potential to migrate offsite (Hakkou et al., 2008; Khalil et al., 2013; Obasi and Akudinobi, 2015; Moye et al., 2017; Obiora et al., 2018; Rahman and Ferdos, 2024). Sulphide ores, such as galena, consist of heavy metal constituents, notably Lead, Mercury, Copper, Manganese, Zinc, Nickel. Cobalt, Arsenic, Selenium. Molybdenum, Chromium, Silver, and Vanadium (Davies et al., 2005; El Amari et al. 2014). Certain heavy metals are either required nutrients, such as Cobalt and Zinc, or comparatively innocuous. like Silver. Conversely, substances such as Cadmium, Mercury, and Lead are very toxic.

The mining process, which includes drilling, extraction, and dewatering, as well as leaching from waste rock heaps and tailing dams, causes changes in water quality and quantity. Miners inject contaminants directly into water bodies, causing water pollution (Ali et al., 2018). The mining operations in the study area have a negative impact on the health of the Funakaye population, resulting in conditions such as kidney stones and abdominal discomfort. These illnesses are caused by the pollution of groundwater that people commonly consume. In some areas. community members experience incidents of greenhouse gas emissions due to industrial and mining activity, resulting in cough and throat discomfort. The extent of contamination caused by mining activities in Funakaye L.G.A. is challenging to assess due to insufficient pre-mining groundwater quality data, lack of enforcement of regulations, and community awareness programmes. The

objective of this study is to determine the heavy metal concentration and pollution of groundwater due to mining activities from selected boreholes in Funakaye L.G.A., Gombe State.

# Hydrogeology

Groundwater is a crucial resource for drinking water, irrigation, and industrial purposes, particularly in areas with scarce surface water (Delgado et al., 2010; Ghalib, 2017). The chemistry of groundwater determines its consumptive use. including domestic. agricultural, and industrial purposes (Krishna Kumar et al., 2014). However, population growth and industrialization have led to intense stress on groundwater resources, making some water unwholesome for human consumption (Tiwari et al., 2015; Khan and Jhariya, 2017). The study area's primary water supply is groundwater, and there is a rapid increase in number of boreholes to meet demand. Groundwater recharge takes place through direct seepage or infiltration, which originates from rivers due to their hydraulic contact. Groundwater circulation is localized due to hills serving as groundwater divides and circulates through quartz veins and fissures, known as fault-brecciated zones. The speed of groundwater circulation is unknown, and domestic wells may not have received pollutants yet. Mining waste pollution in the area can negatively impact users' health, as Sulphide oxidation leads to low pH in water, resulting in the dissolution of metals in groundwater (Muthuminal and Mohana Priya, 2022).

**Occurrence of Groundwater Contamination** Groundwater is considered a reliable source of fresh water, and its availability is usually regulated by aquifer characteristics, topography, subsurface activities, climate, and several geochemical processes. The major Emerging Contaminants (ECs) come from heavy metals, antibiotics, fire retardants, pesticides, sunscreens, disinfection byproducts, and sediment (Pradhan et al., 2023). Ground water contamination can originate from natural (geogenic) or anthropogenic sources. Geogenic Groundwater Contaminants (GGCs) have an impact on drinking water availability and safety, with up to 60% of groundwater sources in some places polluted at higher rates than recommended. As a result, an estimated 300-500 million people are at danger of serious health consequences and early death. The most

common forms of geogenic contamination with human health impacts are elevated concentrations of heavy metals such as arsenic, lead, nickel and fluoride (Mukherjee *et al.*, 2024).

## **Contaminants Migration in Groundwater**

Groundwater contamination has long been a global issue. Contaminants travel and change in soil and groundwater ecosystems, posing possible environmental dangers to humans. Groundwater contamination can result from both point and non-point sources, such as mining spills and agricultural waste (Zhao et al., 2024). Contaminants enter the groundwater through the unsaturated soil zone to the water table, which determines the amount of material that should enter the water from the soil (USGS. surface 2008). Groundwater contamination is on the rise globally due to industrialization and human activities, and these contaminants can be categorized into three main types: chemical contaminants, biological contaminants, and radioactive contaminants. Although they may be roughly divided into three categories: chemical contaminants, biological contaminants, and radioactive contaminants. These contaminants originate from both can natural and anthropogenic sources (Elumalai et al., 2020). Natural causes of groundwater pollution include saltwater, brackish water, low-quality surface waters, and mineral deposits. Human activities, such as aquifer depletion leading to saltwater intrusion, acid mine drainage from mineral resource exploitation, and hazardous chemical leaching from excessive irrigation, can disrupt the natural environmental balance, potentially leading to serious contamination of these natural sources (Li et al., 2018; Su et al., 2020; P. Li et al., 2021).

### Heavy Metals

Heavy metal concentration in water is essential to determining the role of mining activities on water quality. Metals are essential components of human physiology; however, some are needed in minute quantities. Higher concentrations of these metals can lead to a multitude of health issues (Mshelia et al., 2024: Singh et al., 2024). Heavy metals are the pollutants, which are widely common distributed in the environment. As the world's population grows, advancement and industrialisation accelerate, becoming one of the primary causes of water pollution. Water is polluted by increased concentrations of heavy metals and metalloids released from mine tailings, disposal of high metal wastes, growing industrial areas, leaded petrol and paints, inland fertilizer use, animal manures, Ewaste, sewage sludge, pesticides, wastewater irrigation, coal and so on (Anubhav et al., 2022). The level of these metals in the area has increased in the past decades as a result of human activities such as mining. Heavy metals are a major source of Acid Rock Drainage (ARD) indicators in natural waters due to mining and industrial waste disposal and are considered highly toxic to aquatic organisms. Due to their non-biodegradability, these elements' compounds remain suspended or partially dissolved in water columns, leading to their accumulation in many aquatic organisms (Luo et al., 2020; Hu et al., 2022).

#### MATERIALS AND METHODS The Study Area

Funakaye local government area, is in Gombe State, which is in the northeast geopolitical division of Nigeria. The town of Bajoga serves as the headquarters of the LGA, and the area encompasses several towns and villages, including Ashaka, Maraba, Bajoga, Tango, Wawa, and Kupto. The area has a history of limestone and gypsum mining activities. Currently, Ashaka Cement Industry operates a large-scale mining company that mines gypsum and limestone in the area. Funakaye LGA shares borders with the Gongola River and the Dadin Kowa Lake and is home to the Funakaye Emirate. The LGA boasts an estimated population of 327,300 (NPCN, 2016) inhabitants, with the most populous ethnic affiliation in the area being members of Hausa and Fulani ethnic the groups.

Funakaye LGA sits on an area measuring 1,275 km<sup>2</sup> (NBS, 2016) and witnesses two major seasons: the dry and wet. The average temperature in the area is 33 degrees Celsius, while humidity levels average 21 percent. The soils in the study area consist mainly of clay with fewer patches of laterite, mostly in hilly areas. Farming is a major economic activity for the people of Funakaye LGA, with crops such as sorghum, maize, beans, and millet grown in the area. The LGA has substantially large deposits of minerals such as gypsum,

bentonite, and limestone. The area also hosts the Lafarge Africa-owned Ashaka cement plant, which contributes massively to the economic development of the region.

#### Sample Collection

Three sampling sites were selected using the global positioning system, GPS, as shown in Table 1. The distance from the mining site to the first point (i.e., from the mining site to Mangari) is about 7.54 km; from Mangari to Julahi is 1.939 km; and from Julahi to Mangha is 4.085 km.

#### **Groundwater Sampling**

Three groundwater sources (boreholes) designated for potable consumption were identified. Each point was sampled three times, with a four-day interval between each sample collection. The sample sites were assigned names and serial numbers according to their locations inside Funakaye. All samples were obtained from operational boreholes. The samples were collected in 75cl washed, high-density polyethylene containers. To avoid external contamination during the sample collection, the following measures were taken:

- a. The samples were obtained directly from the boreholes after allowing the water to run for at least 5 minutes (Reimann *et al.*, 2003).
- b. All the sampling containers were rinsed three times with the very water to be sampled before every sample was collected.
- c. Changing of hand gloves after each event to avoid cross contamination.
- d. Before capping, we filled the sample bottles completely to ensure there was no air space left. This was done to prevent the water from

mixing with the air during the sampling process.

#### Sample Preservation

Water samples meant for the heavy metal analysis were acidified with 1 ml HNO<sub>3</sub> to achieve a pH of 2.0. The addition of acid to the water sample was to keep the metal ions in the dissolved state as well as to prevent microbial activities (APHA, 2005). The samples were kept in an ice chest loaded with ice blocks, transported to the laboratory, and stored in a refrigerator at 4°C until they were analyzed.

#### **Heavy Metal Analysis**

Nine samples were taken and placed in 75cl plastic bottles and transported to the Department of Soil Science, Ahmadu Bello University, Zaria for heavy metal analysis. The test was conducted using Varian AA 240FS Atomic Absorption Spectrophotometer (AAS) machine. The 75cl unfiltered water sample was transferred into a 1000ml beaker, to which 2 ml of concentration HNO<sub>3</sub> was added and heated to boil on a hot plate until the volume was reduced to about 15-20 ml. This was cooled and transferred to a volumetric flask

and made up to the mark. Standard solutions of suitable strength for individual metals were prepared. The blank, standard solutions, and samples were aspirated into the flame atomic absorption spectrophotometer. The calibration curves were plotted, and the concentration of the samples were obtained by extrapolation.

#### **Preparation of Calibration Curve**

To determine the concentration of heavy metals in the sample solution, calibration curves were created. A variety of working standards were used to calibrate the device. Each metal's working standard solutions were made from standard solutions of their respective metals, and their absorbencies were determined using Atomic Absorption Spectrometry (AAS). By graphing absorbance as a function of metal standard concentration, a calibration curve for each metal ion to be examined was created.

#### **Statistical Analysis**

R Studio v4.4.2 was used to conduct statistical analysis. The statistical tests employed were the Chi-square and the student T-test which are typical Parametric tests of Homogeneity carried out for normally distributed data. The student T-test was chosen against the Z-test because the sampled data were less than 30. Chi-square, T-test, and correlation analysis was used to test for data variation between variables for heavy metals analysed.

#### **RESULTS AND DISCUSSION**

The statistical analysis for the chi-square result shows BB1, 1.201, BB2, 0.364, and BB3, 0.537. The critical value, calculated at the 95% level of confidence and a significance level of 5%, is 12.592. This implies that the X2 value is below the critical value, indicating a lack of significant difference between the samples. The t-test results show BB1, 0.323, BB2, 0.272, and BB3, 0.068, with a critical value of 2.172 at the 95% confidence level and a significance level of 5%. This means the T- value is less than critical, which means there is no significant difference between the samples.

# Heavy Metal Concentrations in the water samples

The heavy metals identified in the water samples collected in the study area are iron, copper, zinc, cadmium, chromium, lead and arsenic.

#### Iron

The concentration of iron (Fe) in the water samples varied from one point to another; sample BB2 recorded the highest mean value of 0.49 mg/l, BB1 recorded the lowest of 0.369 mg/l, and BB3 recorded a mean value of 0.428 mg/l. This indicates that the values exceed the WHO and NESREA standard value of 0.3 mg/l for drinking water (Figure 3) thereby higher source of suggesting а iron contamination. This outcome is also in line with research done by Bawa et al. (2019) in Taraba and Adamawa states, which found an elevated Fe content in groundwater due to mining operations.





The presence of a high Fe concentration in the groundwater may be due to the natural geology dissolution of iron minerals from rock and soil, precipitation/run off and infiltration activities, use of galvanized materials in handpump construction, agricultural activities and mining activities of the area (Ocheri, 2010; Blarasin et al., 1999). Iron is an essential element in drinking water and food for almost all living organisms as it participates in a wide variety of processes. including metabolic oxygen transport, deoxyribonucleic acid (DNA) synthesis, and electron transport (Zeidan et al., 2024). However, due to iron's capacity to generate free radicals, its concentration in bodily tissues must be carefully managed since excessive levels might result in tissue damage. Iron metabolism disorders are prevalent human illnesses that include a wide array of conditions with varying clinical symptoms,

from anaemia to iron excess, and potentially neurodegenerative diseases (Abbaspour et al., 2014; Rahman et al., 2024). This study revealed a maximum iron concentration of 0.49 mg/L and a minimum concentration of 0.36 mg/L, which is notably lower than the findings of Rahman et al. in 2024 and Merrill al. in 2011. who reported iron et concentrations of 1.9 mg/L and 2.0 mg/L in groundwater Jalalabad potable from Cantonment in Pakistan and rural Bangladesh, respectively.

## Copper

The concentration of copper (Cu) in the water samples varied from one point to another; BB3 had the highest mean value of 0.102 mg/l, BB1 had the lowest of 0.063 mg/l, and BB2 had a mean value of 0.085, showing that the value was less than the WHO and NESREA standard limits of 1.2 mg/l (Figure 4).

Consumption of this water would therefore not cause adverse effects on consumers health. Osafo (2011) reported similar results from studies in the East Akim Municipality. Sampling points BB3 recorded the highest mean values, suggesting that the proximity of these sampling points made it easier for them to be influenced by the same conditions levels leading to similar of copper concentrations. This difference in the copper concentrations was significant, attesting to the difference in factors that affect the concentration of heavy metals such as copper. Both natural sources and human activities can release copper into the environment. These include mining, metal production, wood production, and phosphate fertilizer production. Human activity and natural releases of copper lead to its widespread presence in the environment, particularly near mines, industrial settings, landfills, and waste disposal sites (NRC, 2000; Kegley *et al.*, 2009; MDH, 2024).

#### Zinc

Sample BB2 recorded the highest mean zinc concentration of 0.178 mg/l while BB3 recorded the lowest concentration of 0.009 mg/l, and BB1 recorded a mean concentration of 0.134, all of which are below the WHO and NESREA standard values of 3 and 5 mg/l respectively (Figure 5).

Due to lower concentrations of zinc in the samples there is no detrimental effect when the water is used for domestic and other purposes at the level obtained in this study. Results obtained in this study are similar to reports by Ankomah-Appiah (2011). However, they fall significantly short of the results obtained by Osafo (2011) from surface water in the East Akim Municipality. The highest mean zinc concentration recorded at sample point BB2, may be due to their location down a slope. Therefore. contamination from either anthropogenic or natural processes in the area could be easily leached or runoff down the slope. The difference in the values recorded at the sampling points was significant, inferring that the conditions that contribute to the concentration of zinc in the study area differed greatly. Variation in terms of runoffs and flows has the potential to increase the level of contaminants in a water body.

#### Cadmium

The concentration of Cadmium (Cd) in the water samples varied from one point to another; BB1 recorded the highest mean value of 0.011 mg/l, BB2 recorded the lowest of 0.004 mg/l, and BB3 recorded a mean value of 0.008, indicating that the values are greater than the WHO's and NESREA standard values of 0.003 mg/l for Cd in drinking water (Figure 6). The result is also consistent with a study done by Usman *et al.* (2020) in Gombe state, which found greater Cd concentrations in groundwater due to mining activity.

The Cadmium concentration remains constant regardless of the sample point and sampling time. Mining and other factors, such as natural geology and water flow, increase the concentrations of cadmium. Therefore, as far as cadmium is concerned, the water is not safe for human consumption due to the Cd concentrations that is above the standards of WHO and NESREA.

#### Chromium

The concentration of chromium (Cr) in the water samples varied from one point to the other; the highest mean value of 0.793 mg/l was recorded at BB2, while BB3 recorded the lowest of 0.489 mg/l, while BB1 recorded a mean value of 0.527, which shows the value is greater than the standard values of 0.05 mg/l and 0.03mg/l set by WHO and NESREA (Figure 7).

Although chromium does not play a major role when it comes to heavy metals that affect adversely the health of consumers, it is an important element to monitor due to its indicative role. Chromium concentrations in this study ranged from 0.489 mg/l to 0.793 mg/l. Significant differences in concentrations were observed. BB2 sampling points recorded the highest mean concentrations. The natural geological structure of these areas as well as

pollution from anthropogenic activities could contribute significantly to the contamination of water bodies with chromium and many other metals; however, these concentrations did exceed the WHO and NESREA standard of 0.05 mg/l and 0.03 mg/l respectively for drinking water. The excess of these detection limits for drinking water in the study area could potentially impact the health of consumers.

#### Lead

The concentration of lead (Pb) in the water samples varied from one point to another; BB3 recorded the highest mean value of 0.428 mg/l, BB1 recorded the lowest of 0.181 mg/l, and BB2 recorded a mean value of 0.341, indicating that the value exceeds the WHO and NESREA standard value of 0.01 mg/l and 0.015 mg/l respectively (Figure 8). This finding is also in tandem with the study conducted by Bawa *et al.* (2019) in Taraba and Adamawa states, which recorded a higher Pb concentration in groundwater due to mining activities.

Lead is one of the most prevalent metals in the earth's crust, with an average concentration of 13 mg/kg. Food ingestion, dust and dirt accounts for 80% of daily lead intake by humans (FDE, 2008; WHO, 2023). Avoiding its intake is crucial due to its carcinogenic properties. The recorded values ranged from 0.181 mg/l to 0.428 mg/l, surpassing the WHO and NESREA recommended limit of 0.01 mg/l and 0.015 mg/l for lead in drinking water respectively. The results indicated a higher

level of Pb contamination in the study area. Mining and other factors, such as natural geology, contribute to an increase in lead contamination levels globally (Gupta and Nikhil, 2016; Abanyie *et al.*, 2023).

## Arsenic

Arsenic (As) concentrations in the water samples varied from one location to another; BB3 recorded the highest mean value of 1.115 mg/l, BB1 the lowest at 0.748 mg/l, and BB2 has a mean value of 0.887 mg/l (Figure 9).

Long-term exposure to low levels of arsenic through drinking water can result in skin cancer (WHO, 2023; Rahimi Kakavandi et al., 2023), and there is also evidence of an increasing risk of bladder, kidney, liver, and lung tumors. The arsenic concentration in this study ranged from 0.784 mg/L to 1.115 mg/L, indicating higher concentrations than the WHO and NESREA standard limits of 0.01 mg/l for Arsenic in drinking water. Therefore, the water samples contain significant Arsenic concentrations. This outcome is also in line with research done by Eze, P.N. et al. (2022) in Northeastern Nigeria, which found an elevated As content in groundwater due to mining operations. Using water from these sources for domestic purposes, including drinking, may lead to fatal cases of arsenic poisoning. The high concentration of As in the groundwater could potentially be attributed to the gold mining, sulfide mineral oxidation, geogenic leaching, natural geology of the area and the water flow in the study area (Blarasin et al., 1999; Tabelin et al., 2018; Usman et al., 2020).

# Cumulative Toxicity of Multiple Heavy Metals.

Research indicates that co-exposure to heavy metals in groundwater leads to greater-thanadditive toxicity through common oxidative stress pathways, competitive metal transport systems, and cumulative DNA damage (Wang et al., 2023; Jaishankar et al., 2022). The combination of As, Pb, and Cd accelerates lipid peroxidation in kidney cells by 40-60% compared to individual metals. In Bangladesh, populations exposed to all three metals develop chronic kidney disease 3.2 times faster than those exposed to only one metal (Ahmad et al., 2024; Rahman et al., 2023). New studies reveal that Cr(VI)-As co-exposure increases bladder cancer risk by 4.7-fold in Taiwanese populations due to strand breaks and As inhibiting repair enzymes. This combination is classified as a Group 1 carcinogenic combination by IARC (Lin et al., 2023; IARC, 2023). Additionally, Fe-Cu interactions produce hydroxyl radicals, leading to 30% more iron deposition in livers of copperexposed individuals. This explains the faster development of cirrhosis in Indian populations with dual exposure (Zhang et al., 2024; Mehta et al., 2023). Recent studies show that Cd-Pb coexposure causes 50% more bone accumulation than expected due to common calcium transport pathways, leading to osteoporosis and renal failure in Chinese mining districts (Bonewald et al., 2024: Li et al., 2023). Zinc supplementation can lower Cd absorption by 35% in contaminated

areas, but high zinc intake can cause copper deficiency anemia within 8 weeks (Vesey, 2023; Johnson et al., 2024). A 2024 meta-analysis found that children exposed to Pb-As-Mn had 11.3 points worse IQ scores than those exposed to single metals (Grandjean et al., 2024; Chen et al., 2023). Advanced neuroimaging suggests synergistic injury to the basal ganglia and hippocampus is responsible for the increased risk of cancer. The As-Cr-Cd-Ni combo activates all 10 cancer markers simultaneously (Hanahan et al., 2023). Population studies in Chile show a 5.8-fold increase in liver cancer incidence when all four metals are present (Aguilera et al., 2024). New animal models also show Pb-As-Cd combinations lower sperm counts by 72% compared to controls. Birth defect rates in Michigan's Flint cohort are 2.9 times higher than expected (Pant et al., 2023; Hanna-Attisha et al., 2024).

# CONCLUSION

Groundwater contamination of some selected boreholes was assessed in Funakaye L.G.A in Gombe State to determine heavy metal contamination and the study's results indicated the presence of certain heavy metals in the study area, including Fe, Cd, Cr, Pb, As, Zn, and Cu, The concentrations were compared to the WHO and NESREA standard limits for quality drinking water and the results indicated that heavy metal concentrations in the boreholes were generally high, with Fe ranging from 0.369mg/l to 0.490mg/l, Cd ranging from 0.008mg/l to 0.011mg/l, Cr ranging from 0.489mg/l to 0.793mg/l, Pb ranging from 0.181mg/l to 0.428mg/l, and As ranging from 0.748mg/l to 1.115mg/l, thus exceeding the WHO and NESREA recommended limits. Zn and Cu concentrations in the samples were found to be lower than the recommended limits for drinking water, with Zn ranging from 0.009mg/l to 0.178mg/l and Cu from 0.063mg/l to 0.102mg/l. The data from the study indicated that there is heavy metal pollution in the studied boreholes, which may be attributed to the mining activities taking place and natural geology in the study area, indicating that pollutants have leached into the groundwater sources. The presence of these heavy metal pollutants in the groundwater is an indicator of the potential health risks that can be associated with the consumption and uptake of these metals, which can cause so many illnesses such as upper respiratory tract infection, nasal membrane irritation, haemolytic mucous anaemia, constipation, anaemia, high blood pressure, low sperm count, cancer of the nasal cavity and lungs, infant mortality, pancreatitis

and damage of hepatic parenchyma in both humans and animals.

#### Recommendations

Based on the findings of this study, the following recommendations are made:

- a. A continuous monitoring strategy for water resources management be designed to guarantee that relevant measures are chosen and performed in the area and on time.
- b. To prevent contamination and further exposure to heavy metal pollution in the study area, motorised deep boreholes should be drilled far away from the contaminating locations.
- c. The government through local community leaders should raise public awareness about the potential risk of groundwater pollution. And to provide means for treating polluted water before consumption.
- d. Standard practices for mining activities should be ensured including establishing measures against environmental pollution or buffer zones if necessary.
